## 1. Introduction

The Smart Transportation Alliance (STA) has served as partner of the EC-funded frontierCities2 (fC2) Incubation & Acceleration Programme<sup>1</sup> (2016-2018) which has supported 18 FIWARE-supported start-ups in the Smart City domain.

Within the Programme, a task to map the needs of the cities (City needs mapping) has been undertaken with the objective of highlighting mutual opportunities for cities and start-ups in terms of successful implementation of FIWARE–based solutions<sup>2</sup> in the areas of:

- Transport and Mobility;
- Environment;
- People;
- Living;
- Governance;
- Economy.

The methodology followed has been based on a common online questionnaire submitted to both cities and start-ups. In relation to specific issues, cities have indicated how much importance they attribute to them, while the start-ups have indicated how much effectively they expect their solution can perform. Results have been matched and scores have been calculated, with a final output presented in both visual and quantitative terms. The final matching has been presented both for the single cities and for the single start-ups/solutions, in order to allow analysis and considerations from different angles. In particular, 'matching tables' have been produced as immediate and simple tool to report the results of the analysis.

Results are heterogeneous both from the city and the start-ups perspective, with different degrees of matching between the city needs and the capabilities of the solutions proposed.

## 2. Start-ups and solutions

In the following table are briefly described the 18 start-ups joining the fC2 Accelerator and their solutions.

# 3. The City Needs Mapping survey

The City Needs Mapping survey has been conducted by submitting two separate on-line questionnaires to cities and start-ups from May to November 2018, through the SurveyMonkey platform (https://www.surveymonkey.co.uk). The Smart City domain's areas analysed are the following:

- Transport and Mobility;
- Environment;
- People;
- Living;
- Governance;
- Economy.




Figure 1 City Needs Mapping methodology scheme

The questionnaires submitted to cities and start-ups differ for the type of question. In fact for cities, the focus is on the importance they attribute to the different issues listed, while for start-ups the focus is on the expected effectiveness of the solutions in addressing the single issues. The methodology used is synthesised in Figure 1.

The survey has been sent to a list of more than 50 cities, mostly European, selected among the frontierCities2 consortium's contacts or approached during project summits and events. Furthermore, the survey has been



also disseminated through the network of POLIS - Cities and Regions for Sustainable Transport. In total, the following 19 cities have participated to the survey:

- Winterthur (Switzerland);

Nevertheless, results (and then the matching with the start-ups' solutions) are available only for 14 cities, as five cities did not complete the full questionnaire.

All frontierCities2 start-ups completed the survey with the answers having been qualitatively checked by the commercial coaches in order to avoid 'optimism' bias. Also the answers from the cities have been qualitatively checked in order to avoid inconsistencies.

The answers collected in relation to the several issues presented are qualitative and the following scales have been used:

#### For cities:

- Not so important; slightly important; important; fairly important; very important

For start-ups:

- Slightly effective; effective; fairly effective; very effective

Colours are used in <u>matching tables</u> to ease the visualisation of the matching. Blank cells indicate issues not addressed by any feature/functionality of the solution.

Nevertheless, also quantitative indicators are calculated for cities and start-ups.



For cities:

• **Start-ups matched** – Number of start-ups whose solution addresses the issue (all levels of effectiveness admitted). As the indicator aims at providing a measure of potential fruitful cooperation, it does not take into account the matching between solutions and issues considered by the city as "not all important". This holds also for the second indicator.

• Average value of the matching – It is the average value of the expected effectiveness of the different solutions matching the specific issue (obtained attributing the following scores 1; 2; 3; 4.

For start-ups the indicators are:

• **Issues matched** - Number of issues matched by the solution features/functionalities.

Analogously to the indicator for cities, it does not take into account the matching between solutions and issues considered by the city as "not all important". This holds also for the second indicator.

• Average value of the matching - It is the average value of the expected effectiveness of the solution in relation to the city needs (based on the scores presented above).

The matching tables presents the results sorted according to the colour scale presented above. Therefore in the tables for cities, the results are sorted in order of importance, from the issues deemed to be 'very important' to those considered not so important. In the tables for the start-ups results are presented moving from issues for which the solution is expected to be 'very effective' to issues for which the solution is expected to be slightly effective

In Figure 2 is reported an example of a matching table for a specific city (Barcelona) and fa specific start-up (Bustimize).

## 4. Results for cities

Results are quite **heterogeneous** in terms of importance attributed by the cities to the different issues and therefore in terms of matching degree. The priorities identified (red coloured) are mostly transversal to the Smart City's areas analysed, with the exception of Helsinki and Barcelona where they almost entirely relate to the mobility area. Heterogeneity also exists in terms of range of scale used, with some cities giving judgments from 'not so important' to 'very important' and others mainly concentrating mainly on the upper part of the scale.

The cities of Friedrikstad, Winterthur, Copenhagen, Barcelona and Letterkenny are the only ones considering some presented issues as 'not so important'. In the case of the survey filled by the city of Helsinki, several issues have not received a judgment; in the related table, while potential indicators have been reported, the cells have been left in blank.



As examples of **high degree of matching** it can be cited the case of Patras and Messina for what concerns the '**city image**', as the issue constitutes a priority (red coloured) and is linked to a high 'average value of the matching' with the potential solutions.

Analogously, high degrees of matching can be identified in Naples, Winterthur, Helsinki and Malaga in relation to the **info mobility** issue and in Kalamata and Malaga for what concerns the **'operator business'** issue. Finally, a high degree of matching is reached in Copenhagen and Barcelona in relation to the issue of the **emissions**.

In Figure 4 the example of Málaga is presented, while all the matching tables are reported in Annex I.

# 5. Results for start-ups

The matching results, analogously to what was observed for the cities, are **heterogeneous in terms of effectiveness** attributed to the solutions in addressing the city issues, **as well as in terms of scale range used**. Therefore each start-up deals with different conditions in terms of potential clients and specific segment/issue to focus on, depending on whether the solution is substantially aligned with the city's priorities or falls into areas not slightly considered or not considered at all by the city. In the matching tables, the white cells means that the start-up indicated that issue as not being connected with the solution's field of application.

**Some solutions cover almost entirely the smart city issues** (for example, it is the case of Acousticity, Fliware, MUV, CASMOB), although with different degree of performance (for example, the first two solutions present lower 'average value of matching' compared to the other ones). **Other solutions are more specialised** in some smart city issues (e.g, greenApes, FI-Assist, Kissmibike, Nowlog); this implies higher 'average values of matching' compared to the previous group of solutions, although different potential performances are registered (greenApes and Kissmybike perform better than the others).

In Figure 5 it is reported the example of greenApes. All the matching tables are reported in Annex II.

# 6. Conclusions

The 'City needs mapping' tool proved to be simple and immediate to explore potential opportunities of cooperation between cities and start-ups in the Smart City domain, at least as preliminary basis of discussion. It could help the cities to orient policies and interventions in specific issues according to the potential solutions available, while for the start-ups it could constitute a useful tool to identify promising specific market segments.

For what concerns cities, the importance attributed to the different issues relevant to the Smart City domain is heterogeneous and consequently the priorities are transversal; this implies heterogeneity also in terms of matching degree. Also for start-ups heterogeneity exists both in terms of effectiveness attributed to the solution in tackling specific issues and in terms of number of city issues that can be addressed, with solutions 'specialised' and other 'multi-tasking'.
